GROUP MEDICLAIM INSURANCE POLICY FOR THE EMPLOYEES AND THEIR DEPENDENTS

OF "SHRI VITTHAL RUKMINI TEMPLES COMMITTEE, PANDHARPUR".

- 1. TITLE: The scheme is titled as "Group Mediclaim Insurance Policy for the employees and their dependents of Shri Vitthal Rukmini Temples Committee, Pandharpur" aimed at providing Medical facilities to employees and their dependents of "Shri. Vitthal Rukmini Temples Committee, Pandharpur" for indoor treatment through Mediclaim Insurance Policy.
- 2. COMMENCEMENT: The scheme will be effective from 20st Jan, 2025 and shall be in force up to 19st Jan, 2026. However the Competent Authority may extend the period up to 6 (six) months in a special case with the approval of the Competent Authority.

#### 3. Scope:

- This policy will cover all the employees and their dependent family members i.e. his/her spouse, dependent parents and children (Up to the age of 26 years), brother up to age of 18 years and sister until she gets married. (Employee + any five members as a for said)
- All new employees who are appointed along with their dependents shall be considered for this policy by the company and will be covered from the date of joining.
- Medical facilities and benefits to all such employees who cease to be in employment of Shri Vitthal Rukmini Temples Committee, Pandharpur due to permanent disability arising out of or in the course of employment, till he/she attains the age of superannuation 58/60 years as the case may be along with his/her family members and dependents, as applicable to employees of Shri Vitthal Rukmini Temples Committee, Pandharpur, shall continue.

#### 4. DEFINITION:

In this scheme unless there is anything repugnant in the subject or context:

- a) "Shri Vitthal Rukmini Temples Committee, Pandharpur"
- b) "Scheme" means "Group Mediclaim Insurance Policy for the employees and their dependents of Shri Vitthal Rukmini Temples Committee, Pandharpur".
- c) Employees of Shri Vitthal Rukmini Temples Committee, Pandharpur means the employees who are duly and directly appointed by the Shri Vitthal Rukmini Temples Committee, Pandharpur & who are in the service of the Shri Vitthal Rukmini Temples Committee, Pandharpur. It will also cover the employees appointed as "the employees who are placed on deputation to Shri Vitthal Rukmini Temples Committee, Pandharpur.
- d) "Hospitalization" means employee undergoing treatment in empanelled hospital as indoor patient (minimum 24hours).
- e) Spouse means wife/husband of the employees, as the case may be, as declared to Shri Vitthal Rukmini Temples Committee, Pandharpur.
- f) "Family means" employee + any of the 5 dependent members as given below:
  - a) Spouse
  - b) Children:
  - 1. Son and daughter up to the age of 18 years only are covered. If son/daughter above 18 years of age are working and in case of married daughter will not be covered under the policy.
  - 2. Son up to the age of 26 years who are bonafide student and who is fully dependent on employee will be covered.
  - 3. Unmarried daughter who is fully dependent on employee up to her marriage will be covered under this policy.
  - 4. Physically Handicapped and mentally retired children who are fully dependent on

employee will be covered under this policy.

- c) Parents (Female employee can choose either Mother + Father or Mother in Law + Father in law) i.e. only one set of parents to be chosen.
- d) Brother till he attains the age of 18 years.
- e) Sister (Divorcee/Widow or until she gets married)
- 5. INSURANCE COVERAGE: WHAT IS If the insured person sustains injury or contracts with any disease and upon advice of Medical Practitioner, he / she or family members have to be hospitalized and to incurred Hospitalization Expenses, then the following in hospitalization expenses shall be payable by the Insurer to that employee/family members.

#### **COVERED**

- 1) Room Rent:- Room Rent at actual expenses.
- 2) Nursing Expenses:- These expenses will be reimbursed subject to specific Recommendation of treating physician / doctors that patient disease is such which require utmost care by a Nurse.
- 3) Medical Practitioner / Anesthetist, Consultant fee.
- 4) Expenses on Anesthesia, Blood Oxygen, Operation Theatre charges, Surgical Appliances, Medicines and Drugs, Diagnostic Materials and X-ray, Dialysis, Chemotherapy, Radiotherapy, Cost of pacemaker, Artificial Limbs, Cost of organs and similar expenses other than those as specifically stated in exclusion(what is not covered) section of the Policy.
- 5) Pre-existing diseases are covered. There will be no exclusion.
- 6) Pre hospitalization cover up to 30 Days and post hospitalization cover up to 90 days.
- 7) Day Care: This covers all medical procedures and treatments or cares which are of the nature of an emergency treatment which is provided in a Hospital but does not necessitate an admission as an indoor patient. Day care facilities would be available for the following medical treatment:

    - b) Corrective surgery for blepharoptosis when not congenital/cosmetic.
    - c) Corrective Surgery for entropion/ ectropion
    - d) Dacryocystorhinostomy (DCR)
    - e) Excision involving one-fourth or more of lid margin, full thickness.
    - f) Excision of lacrimal sac and passage.
    - g) Excision of major lesion of eyelid, full thickness.
    - h) Manipulation of lacrimal passage.
    - i) Operations for pterygium.
    - j) Operations of canthus and epicanthus when done for adhesions due to choric infections.
    - k) Removal of a deeply embedded foreign body from the conjunctiva with incision.
    - 1) Removal of a deeply embedded foreign body from the cornea with incision.
    - m) Removal of a foreign body from the lens of the eye.
    - n) Removal of a foreign body from the posterior chamber of the eye.
    - o) Repair of canaliculus and punctum.

- p) Repair of corneal laceration or wound with conjunctival flap.
- q) Repair of post-operative wound dehiscence of cornea.
- r) Penetrating or Non-Penetrating Surgery for treatment of Glaucoma.
- 11. FESS(Functional Endoscopic Sinus Surgery)
- 12. Fissurectomy/Fistulectomy
- 13. Fracture/dislocation excluding hairline fracture
- 14. Haemodialysis
- 15. Hydroceletomy
- 16. Hysterectomy
- 17. Inguinal/ventral/umbilical/femoral herniarepair
- 18. Laparoscopic Cholecystectomy
- 19. Lithotripsy (kidney Stone removal)
- 20. Liveraspiration
- 21. Mastoidectomy
- 22. Parenteral chemotherapy
- 23. Haemorrhoidectomy
- 24. Polypectomy
- 25. Following Prostate Surgeries
  - a. TUMT (Transurethral Microwave Thermotherapy)
  - b. TUNA (Transurethral Needle Ablation)

- 35. Maternity cover Up to Rs 50,000 for normal delivery and 60,000/- for cesarean deliveries. This cover can be claimed once during the policy for either the delivery or termination of a child. (Pregnancy or lawful termination of pregnancy, up to maximum two pregnancy or surgery and pregnancy surgery related treatment)

The above treatment is required to be taken from an authorized doctor (minimum MBBS degree holder). Condition of 24 hrs. Indoor treatment shall not apply in such cases.

8. Cost of Travel: Cost of Travel of Insured Person: In the event of Insured Person falling sick and requires hospitalization outside the city / town / village, where treatment of the insured person is not possible due to lack of proper facility at that hospital and condition of the insured person is such that it requires immediate medical attention with Intensive Care, the Insurance Co. shall reimburse the cost of journey for Insured Person only to the place of hospital. This benefit will be available only if the insured person is hospitalized as a consequence of emergency sickness but not for treatment of disease or any related disease or a consequential complication thereof, following which the Insured person has been hospitalized. The maximum liability of the company shall be restricted to Rs.25000/- per employee during the period of insurance.

9. Cost of aid: Rs.25,000/- per family insured / per policy period for reimbursement on cost incurred for Artificial Limbs, Wheel Chairs, crutches and Walkers etc. Reimbursement of these expenses will be subject to the limit of sum insured per family and should be duly recommended by the treating doctor.

## WHAT IS NOT COVERED/Exclusion

- 1. Injury or diseases directly or indirectly caused by or arising from or attributable to War, Invasion, Act of Foreign Enemy, War like operation (whether war be declared or not).
- 2. Circumcision except for disease not excluded here or injury, vaccination or inoculation or change of life or cosmetic or aesthetic treatment of any description, plastic surgery except for relating to treatment of injury or illness.
- 3. Cost of spectacles and contact lens, hearing aids.
- 4. Any dental treatment/including root canal except accidental treatment.
- 5. Self-injury and ailments arising out of chronic use of alcohol / narcotic drugs.
- 6. Expenses for any treatment related to Human T-Cell Lymphotropic Viruses types III (III- LB-III) or Lymphadenopathy Associated viruses (LAV) or the Mutant Derivatives or Variations Deficiency Syndrome or any Syndrome or a condition of similar kind referred to as AIDS.
- 7. Expenses on Diagnostic, X-Ray, or Laboratory Examinations unless related to the treatment of sickness or injury falling within ambit of hospitalization of domiciliary hospitalization.
- 8. Expenses on vitamins and tonics unless forming part of treatment for injury or diseases as certified by the attending physician.
- 9. Injury or diseases directly or indirectly caused by or contributed to by Nuclear weapons material
- 10. Any expenses on Naturopathy, Unproven Procedure or treatments, experimental or alternative treatments and medicines including acupressure, acupuncture, magnetic and Ayurvedic related treatments.

## 6. Sum Insured and Buffer/Corporate Sum Insured

Sum Insured: The Scheme shall provide coverage for meeting all expenses relating to hospitalization of beneficiary members up to Rs. 2.00/- Lakh as per the table given in "Section - B, Financial proposal" per family (floater basis).

6(a). Voluntary Top Up Facility- Some employees may prefer top up facility beyond Rs. 2.00/- Lakh cover, the premium towards additional insurance amount will be fully paid by the employee. Shri Vitthal Rukmini Temples Committee, Pandharpur will only co-ordinate for the remittance of amount from the employees to the insurance company. The best selector bidder on award of contract will decide the said amount in consultation with S Shri Vitthal Rukmini Temples Committee, Pandharpur. Shri Vitthal Rukmini Temples Committee, Pandharpur does not guarantee the Number of Employees availing such facility. The insurance company in consultation with Shri Vitthal Rukmini Temples Committee, Pandharpur may fixed the amount for additional premium, which will be not more than the 50% proportionate amount of the premium accepted towards the basic sum insured selected by the Shri Vitthal Rukmini Temples Committee, Pandharpur.

## 7. The following coverage's are required

- a) Pre-Existing Diseases to be covered from Day One.
- b) 30 Days Waiting Period to be waived off.
- c) First One, Two, Three and Four years waiting period to be waived off.
- d) Internal and External Congenital disease to be covered.
- e) Genetical disorders and Stem Cell Implantation Surgeries to be covered.
- f) All Psychiatric and Psychosomatic disorders and diseases to be covered.
- g) Dental treatment only in case of an Accident. It is further added that this is only indicative and any hospitalization claim resulting out of dental Accident should be covered.
- h) Claim Submission clause should be up to 90 days from date of discharge. If due to any unforeseen circumstances, the claim is not submitted within the said period of 90 days, 15 days relaxation will be allowed by the Insurance Company.

- i) Hospitalization expenses of person donating an organ during the course of organ transplant will also be payable limited to the overall sum insured.
- j) Midterm inclusion/exclusion of family members/dependents:
  - i) New born baby to be covered from one month of the date of birth.
  - ii) Newly married spouse from the date of marriage or declaration.
- h) If any employee ceases to be on the rolls of Shri Vitthal Rukmini Temples Committee, Pandharpur due to Resignation/Termination /Death etc. during the policy period, the Insurance Company will refund the amount of premium on pro-rata basis to the Shri Vitthal Rukmini Temples Committee, Pandharpur and insurance cover will be stopped for such employee from the date of Resignation /Termination /Death etc.
- i) Pregnancy surgery and pregnancy surgery related treatment

#### 8. Terms & conditions

- a) Addition and Deletion of Employees & dependents on Pro rata Basis.
- b) The Insurance Company should to coordinate for the claims and they will submit proof thereof.
- c) Insurance Company should also provide dedicated mobile app for this policy.
- d) The Insurance Company should have a 24x7 call center and establish a Grievance redressal mechanism to address the grievance of members. In case of non-settlement of grievances within period of 20 days, they will be liable for penalties as decided by the competent authority and as per the mutually agreed processes in Grievance Redressal Mechanism.
- e) The Insurance Company should indicate clearly in its tender proposal document as to what documents are required to be submitted by employee and their dependents of the companies along with the bills, for smooth settlement of reimbursement claims. The Insurance Company should submit methodology and detailed procedure of cashless and non-cashless claims management. The Insurance Company should also submit hospital list.

#### PART - II

#### GENERAL INSTRUCTIONS

#### 1. SUBMISSION OF PROPOSAL

The financial proposal duly signed on every page including annexure shall be submitted in sealed envelopes clearly super subscribed as "<u>Financial Proposal</u>". All the relevant documents shall be enclosed and the envelopes shall be sealed in an outer envelope bearing the address indicated above. The envelope shall be clearly marked:

"DO NOT OPEN, EXCEPT IN PRESENCE OF THE COMMITTEE." TO BE OPENED on 20/01/2025. at 15.00 hrs. The tender should be signed by a duly authorized representative of the Insurance Company. It shall be certified that the person signing the tender is empowered to do so on behalf of the Company. A copy of the Memorandum and Articles of Association of the Company shall be attached to the tender. The person signing the proposal or any documents forming part of the proposal on behalf of another or on behalf of a firm shall be responsible to produce a power of attorney duly executed in his favour, stating that he has the authority to bind such other person or the firm as the case may be, in all matters pertaining to the contract. If the person so signing the tender fails to produce the said power of attorney, his proposal shall be liable to summary rejection without prejudice to any other right of Shri Vitthal Rukmini Temples Committee, Pandharpur under the law. The proposal shall be filled in by the Insurance Company neatly and accurately. Any corrections or overwriting would render the proposal invalid. Conditional offers / offers which are not in conformity to the prescribed document will be summarily rejected. All the documents submitted with the Tender are to be furnished duly signed on all pages.

The committee, after determining whether the financial proposals are complete and without errors shall determine the lowest financial proposal for conducting negotiation / award of contract and reserves all the rights for the same.

## 7. AWARD OF CONTRACT

The contract shall be awarded to the best bidder, by conveying acceptance of the proposal by Shri Vitthal Rukmini Temples Committee, Pandharpur through registered / speed post / courier. All the terms and conditions as stated in the Tender documents, Appendices and Acceptance conveyed by Shri Vitthal Rukmini Temples Committee, Pandharpur will constitute the contract between the Insurance Company and Shri Vitthal Rukmini Temples Committee, Pandharpur. The selected Insurance Company is expected to commence the Assignment on the date and at the location to be specified in the work order to be issued by Shri Vitthal Rukmini Temples Committee, Pandharpur as per its requirement and on the terms and conditions specified.

#### 8. PUBLIC SECTOR INSURANCE COMPANIES

i) Insurance company should be registered with IRDAI. The Insurer should attach a copy of the license as a proof of its registration.

- ii) Insurance company should have a full-fledged establishment In Maharashtra with experience in conceptualizing, designing and implementing large healthcare schemes and have at least three year experience in catering to health insurance of 10000 families or more under the one group health insurance scheme in 2021-2022, 2022-2023 & 2023-2024.
- iii)Insurance company should have arrangement of healthcare at all the locations where Shri Vitthal Rukmini Temples Committee, Pandharpur offices are located.

#### 9. FORCE MAJEURE

For the purposes of this Contract, "Force majeure" means any unforeseen event directly interfering with the services during the currency of the contract such as war, insurrection, restraint imposed by the government, act of legislature or other authority, explosion, accident, strike, riot, lockout, act of public enemy, act of God, sabotage which is beyond the reasonable control of a Party and which makes a Party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances. The obligations of Shri Vitthal Rukmini Temples Committee, Pandharpur and the Insurance Company shall remain suspended if and to the extent that they are unable to carry out such obligations owing to force majeure or reasons beyond their control. The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event and such impossibility subsists for not less than 90days.

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure. The Insurance Company is entitled to the payments for the portion of the work already completed before the happening of any event constituting force Majeure culminating in termination of contract. Decision of Shri Vitthal Rukmini Temples Committee, Pandharpur in this regard will be final.

#### 10. INDEMNITY

The Insurance Company hereby agrees to keep indemnified and shall keep indemnified and hold harmless, Shri Vitthal Rukmini Temples Committee, Pandharpur and its Directors, officers and employees from and against all and any claims, demands, losses, damages, penalties, expenses and proceedings connected with the implementation of this Contract or arising from any breach or non-compliance whatsoever by the Insurance Company or any of the persons deployed by it pursuant hereto of or in relation to any such matter as aforesaid or otherwise arising from any act or omission on their part, whether willful or not, and whether within or without the premises.

#### 11. OTHER TERMS AND CONDITIONS

Any changes in the terms of the document can only be made in writing and by mutual agreement. This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the laws of India for the time being in force. Any notice, request, or consent made pursuant to this Contract shall be in writing and shall be deemed to have been made when delivered in person or sent by registered/speed post/courier to an authorized representative of the Party. The Services

shall be performed at such locations as specified by Shri Vitthal Rukmini Temples Committee, Pandharpur from time to time. Any action required or permitted to be taken, and any document required or permitted to be executed, under this contract by Shri Vitthal Rukmini Temples Committee, Pandharpur or the Insurance Company, may be taken or executed by the officials authorized. Unless otherwise specified, the Insurance Company, and their Personnel shall pay such taxes, duties, fees etc. as may be levied under Central/State law and the same will not be reimbursed by Shri Vitthal Rukmini Temples Committee, Pandharpur.

# 12. COMMENCEMENT, COMPLETION, MODIFICATION, AND TERMINATION OF CONTRACT, EFFECTIVENESS OF CONTRACT

This Contract shall come into force w.e.f. 20st JAN, 2025

- a. Commencement of Services The selected Insurance Company is expected to commence the Assignment on the date and at the location to be specified in the work order to be issued by Shri Vitthal Rukmini Temples Committee, Pandharpur as per its requirement. If the Insurance Company fails to commence the assignment within the specified schedule as per work order, the contract shall be liable to better minted.
- b. Expiration of Contract Unless terminated earlier, this Contract shall expire at the end of such time period after the effective date as specified.
- c. Modification After award of the contract, any minor changes in the modus of implementation can be agreed to mutually in writing.
- d. Subletting The Insurance Company and TPA shall not sublet, transfer or assign the contract or any part thereof to other party. In the event of the Insurance Company and TPA contravening this condition, Shri Vitthal Rukmini Temples Committee, Pandharpur shall be entitled to terminate the contract and get the work done through other party at the risk & cost of the Insurance Company.
- e. Termination By Company (Shri Vitthal Rukmini Temples Committee, Pandharpur) Shri Vitthal Rukmini Temples Committee, Pandharpur may terminate this Contract, by not less than thirty (30) days written notice of termination to the Insurance Company, to be given after the occurrence of any of the events specified below in clauses (a) to (c) of and sixty (60) days in the case of the event referred to in clause(d):
  - a) If the Insurance Company commits breach of contract or do not remedy/rectify a failure in the performance of their obligations under the Contract.
  - b) If the Insurance Company become insolvent or bankrupt;
  - c) If as the result of FORCE MAJEURE, the Insurance Company are unable to per form a material portion of the Services for a period of not less than (90) days
  - d) If Shri Vitthal Rukmini Temples Committee, Pandharpur, in its sole discretion, decides to terminate this Contract. In the event of termination on unsatisfactory service or in violation of any of the terms & conditions of contract, the Insurance Company will be blacklisted.
- f. Payment upon Termination Shri Vitthal Rukmini Temples Committee, Pandharpur at its sole discretion may decide & pay remuneration for Services satisfactorily performed prior to the effective date of termination provided such termination is not on account of any breach of contract by the Insurance Company.
- 13. OBLIGATIONS OF THE INSURANCECOMPANY The Insurance Company shall perform the Services and carry out their obligations with all due diligence, efficiency, and economy in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate advanced technology and safe methods. The Insurance Company shall always act, in respect of any matter relating to this Contract or to the

Services, as faithful advisers to Shri Vitthal Rukmini Temples Committee, Pandharpur, and shall at all times support and safeguard Shri Vitthal Rukmini Temples Committee, Pandharpur legitimate interests in any dealings with the third parties.

The Insurance Company not to Benefit from Commissions, Discounts, recruitment fee etc.

The recruitment charges of the Insurance Company shall constitute the Insurance Company' sole payment in connection with this Contract or the Services, and the Insurance Company shall not accept for their own benefit any trade commission, discount, or similar payment or any other benefits in connection with activities under the Contract, and the Insurance Company shall use their best efforts to ensure that the. Personnel too shall not receive any such payment/benefit other than as provided by IRDA. Neither the Insurance Company nor their Personnel shall engage, either directly or indirectly, in any such activities which conflicts with their role under the assignment. All transactions between the Insurance Company and third parties shall be carried out as between two principals without reference in any event to Shri Vitthal Rukmini Temples Committee, Pandharpur. The Insurance Company shall also undertake to make the third parties fully aware of the position aforesaid. Insurance Company shall be liable to pay damages to Shri Vitthal Rukmini Temples Committee, Pandharpur for any losses, costs and expenses incurred by Shri Vitthal Rukmini Temples Committee, Pandharpur due to breach of any of the terms and conditions of this contract and failure to perform any of the obligations under the contract. The Insurance Company shall give detailed descriptions of the Services to be performed, period for completion of various tasks, different tasks, specific tasks etc., to be approved by Shri Vitthal Rukmini Temples Committee, Pandharpur.

#### 14. CONFIDENTIALITY AND NON DISCLOSUREAGREEMENT

Each party shall not without prior written consent of the other party at any time divulge or disclose to any person or use for any purpose unconnected with the implementation of the Policy, any information concerning the policy, the services, Proprietary Material except to their respective officers, directors, employers, agents, representatives and professional advisors on a need to know basis or as may be required by any law, rule, regulation or any judicial process.

This Clause shall not apply to information:

- i) Already in the public domain, otherwise than by breach of this Agreement.
- ii) Already in the possession of the receiving Party before it was received from the other Party in connection with this Agreement and which was not obtained under any obligation of confidentiality; or
- Obtained from a third Person who is free to divulge the same and which was not obtained under any obligation of confidentiality. The Insurance Company shall obtain Shri Vitthal Rukmini Temples Committee, Pandharpur's prior approval in writing wherever necessary. Documents Prepared by the Insurance Company to be the Property of Shri Vitthal Rukmini Temples Committee, Pandharpur. All plans, charts, specifications, designs, reports, and other documents and software submitted by the Insurance Company shall become and remain the property of Shri Vitthal Rukmini Temples Committee, Pandharpur, and the Insurance Company shall, not later than upon termination or expiration of this Contract, deliver all such documents and software to Shri Vitthal Rukmini Temples Committee, Pandharpur, together with a detailed inventory thereof. The Insurance Company may retain a copy of such documents and software provided the future use of these documents, if any, shall be subject to the prior written approval of the Shri Vitthal Rukmini Temples Committee, Pandharpur.

#### 15. REMOVAL AND/OR SUBSTITUTION OF PERSONNEL

If Shri Vitthal Rukmini Temples Committee, Pandharpur finds that any of the Personnel has (i) committed serious misconduct or has been charged with having committed a criminal action, or (ii) Shri Vitthal Rukmini Temples Committee, Pandharpur has reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Insurance Company shall, at Shri Vitthal Rukmini Temples Committee, Pandharpur written request specifying the grounds thereof shall provide suitable substitute of the personnel. The Insurance Company shall have no claim for additional costs arising out of or incidental to any removal and/or substitution of Personnel.

#### 16. LIABILITY FOR PERSONNEL

All persons employed by the Insurance Company shall be engaged by them as their own Employees/workers in all respects and the responsibility under any statutory enactments in respect of all such personnel shall be that of the Insurance Company. The Insurance Company shall indemnify Shri Vitthal Rukmini Temples Committee, Pandharpur against all claims whatsoever arising in respect of the said personnel under any statute/law in force.

17. OBLIGATIONS OF THE COMPANY (Shri Vitthal Rukmini Temples Committee, Pandharpur) Shri Vitthal Rukmini Temples Committee, Pandharpur shall provide the Insurance Company such reasonable assistance as may be required in order to carry out the assignment.

Any increase in the statutory taxes, levies, fees at actual will be paid to the Insurance Company and any decrease in levies/tax will be refunded by the insurance company.

## 19. Terms and Conditions of Payment

## 20. CORRUPT OR FRAUDULENT PRACTICES

It is clearly understood and accepted by both parties that this Contract between the parties evidenced by it is on a Principal to Principal basis and nothing herein contained shall be construed or understood as constituting either party hereto, the agent or representative of the other, under any circumstances. The employees of the Insurance Company shall never, under any circumstances whatsoever, be entitled to claim themselves to be the employees of the Shri Vitthal Rukmini Temples Committee, Pandharpur.

#### 22. ARBITRATION

In the event of any dispute arising amongst the Parties, the Parties agree to use their best efforts to attempt to resolve all disputes in prompt, equitable and good faith. In the event the Parties are unable to do so, then such dispute shall be finally resolved as per IRDAI Norms.

#### 23. JURISDICTION

The parties hereby irrevocably consent to the sole jurisdiction of the Courts of Pandharpur only in connection with any actions or proceedings arising out or in relation to this Tender.

#### 24. OTHER
